It would be necessary for that person to respond with keys to the property, and a proper alarm code if applicable.

Date of birth is requested as a form of verification in the event there are multiple people in our system with the same name. Contact information will be kept strictly confidential and only used for notification purposes by law enforcement and/or the fire department.
