

Victim's Compensation

Wyoming participates in the victim's compensation program which is funded through fines and penalties imposed on criminal offenders, no tax dollars are used to fund the program. The Wyoming Victim's Compensation program assists victims of violent with expenses related to the crime. Assistance can include medical and dental, lost wages, counseling, relocation and funeral expenses.

Who is Eligible

- The crime happened in Wyoming.
- Victims who have suffered physical or psychological injury or death as a direct result of a violent crime.
- Application was filed within one year of crime.
- The victim cooperated with law enforcement officials in the investigation and prosecution.

Victim Services in the Casper Police Department will assist all qualified victims in completing victim compensation applications and submitting them for review to the Division of Victim Services.

Protection Orders

Victim Services at the Casper Police Department will provide assistance to individuals who needing to file civil paperwork for protection orders or stalking orders.

What is a protection order: It is a document issued by the court, to help you protect yourself from someone who is abusing or harassing you.

How do I get one? You may pick up an order to complete at the police department and someone within our unit will assist you in completing the document correctly and how to file it with the courts.

Cost to you: There is no cost to the victim to file a protection order.

Call Victim Services if you need assistance with a protection order.

Victim Rights

- The right to be treated with compassion, respect and sensitivity within the criminal justice system.
- The right to know the whereabouts of the offender and the current status of the case.
- The right to receive restitution from offenders.
- The right to know all rights under the laws including information about services and victim's assistance at the local level.
- The right to know about victim compensation.
- The right to reasonable protection and safety and the right to know of legal recourse if threatened.
- The right to prompt return of property.
- The right to preservation of employment while participating in the criminal justice process.
- The right to be informed about the opportunity to make a victim statement at sentencing and parole hearings; and
- The right to be present at trial.
